a. How a letter from the BAAA to the BOC suddenly appeared at the BOC AGM. This is no big deal, however, the correspondence was not approved by the Executives or the body and was the pipe dream of two or three members and it achieved their goal;

b. How during an IAAF visit and as a private meeting was in session between the IAAF representative and a Council member, an executive barged in disrupting the meeting, pot-cake style;

c. A program was produced displaying PUMA'S name on ADIDAS'S uniform;

d. Numerous stories by executives stating disruptive actions, and embarrassing moments in front of PUMA representative.

Members, at this meeting moved a vote of no confidence and three members were impeached. It is a sad state to be rejected by a body who six months earlier accepted you as young and rising stars and future leaders of the organization. We all know what transpired and how the Association was placed in courts, how the courts ruled first, and how it changed and gave a complete opposite ruling, all in the space of one week.

Nothing changed at meetings; hence, members in another duly called meeting moved a no confidence vote in the entire executives during a meeting where the true colors of the three impeached executives was seen by all present. This motion was unanimously accepted with one abstention.

This motion is a great call, because it gives the membership a chance to correct what seemed to be a grave mistake, although at first it looked like a genius planned it.

And the unanimous passing of the motion demonstrates the frustration of members present, not affiliated with the -----, who also voted for the motion.

So let the truth be told and let the membership decide our fate again. Let us work together; let us show the members, the government, the country and our international affiliates that allowing.

The Bahamas to host the IAAF World Relays for two consecutive years was no mistake.

A lot of planning time has been lost, a lot of bad mouthing, by outsiders and insiders have caused us to lose creditability and funds; we have to go into 2014 as a TEAM.
